## 1340. Minutes Of Meeting Held On 6th December 2016

The minutes for the meeting held on 6th December 2016 were approved and signed as a true record.

### 1341.Matters Arising (not otherwise noted on the agenda)

• The clerk reported that a 'zero' rough sleeper estimated had been submitted.

#### 1342.Traffic And Parking

Cllr Burley reported that she had a discussion with Mr Rob Brown, from Highways, East Riding Council and felt that the issue regarding investing in land which is not owned by the parish council was minor, as East Riding could do very little with grass verges that they owned. Cllr Francis also raised issues with on-going maintenance. The council decided that they needed to consult with residents before they proceeded with this plan. Cllr Francis also suggested that we send a questionnaire asking our residents on their vision for the village. It was also suggested that extending the car park is incorporated into our village plan.

#### 1343.Highways

Cllr Burley reported that expenditure on Wolds View has been approved. This involves digging out the problem area to prevent recurrence.

Some work has been done on the verges as well as salt piles provided throughout the parish. Also the clerk noted that a local resident has reported the encroachment of the hedges by the fish ponds at Ousethorpe to East Riding Council and this has been handled by the Street Scene Team. There is still an outstanding issue regarding self-seeded growth

Cllr Francis reported that a new bench is being installed in Givendale.

Cllr Brooks asked about the damaged road sign and stated he would like to recover the sign so that it can be used as part of the repair. Cllr Burley to investigate.

#### 1344.Broadband

Cllr Burley reported areas within the parish without superfast broadband are on East Riding's list. This includes houses in Millington. There is some money available and we should hear whether we have been successful in January.

#### 1345.Budget & Precept

Cllr Cllr Cheney proposed a budgeted expenditure £4,300 for 2017/18. This was seconded by Cllr Brook. The majority agreed. Cllr Brook proposed this be met by a precept demand of £4,300. Cllr Francis seconded this. Again the majority agreed. This will mean residents will pay approximately £42 per household this year.

#### **1346.Bonfire Night Celebration**

This was deferred as Cllr Willoughby was absent. Cllr Francis reported that he thought it was wonderful.

#### 1347.Allotments

The council approved the revised Tenancy Agreement. Cllr Cargill offered to do some research on comparable allotments to help advise council on setting an appropriate rent review for 2018/19.

#### 1348.Emergency Plan

Cllr Burley reported that there was no further progress.

#### 1349.Landscape Institute Project

Cllr Francis: no further progress to report. This is not going to be actioned until March.

#### 1350.Millington Wood

Cllr Burley reported that Patrick Wareham has advised that the council have found some money to repair the upper paths. With a bit of luck this should happen in February.

#### 1351.Website

The clerk reported that she has signed an OS Public Sector End User Licence on behalf of the council. Parish map can be used as is. Cllr Cheney will be able to use it to develop Givendale map.

Cllr Burley has re-written St Margaret & Village Hall pages.

#### 1352.Casual Vacancy

The council agreed to adopt ERNLLCA Advisory Note AN004.

The council approved the Co-Option Procedure.

#### 1354. Yorkshire Day Celebrations
